7.1 Ferry Service Letter

Commissioner Anderson reported he has not done any further investigation on the town sign. Chair Panio has been in discussion with Leah Kleinhans, manager of the Creston Valley-Kootenay Lake Economic Action Partnership (EAP) regarding gateway signage.

7.5 Rental Rate Discussion

Chair Panio provided an update regarding the Community Centre rental rates. Chair Panio will review the RDCK Recreation Fee Guide in determining the new fee schedule for the Community Centre. The revised Community Centre rental fee schedule will allow for considerable flexibility in rental rates depending upon the user groups involved.

7.6 Water & Drainage Advisory Board

Chair Panio reported that 3 residents have stepped forward to become members of the Water & Drainage Advisory Board. The first meeting date is scheduled for Friday, Dec. 1, 2023.

The Society is providing free radon tester to Libraries. Chair Panio will contact the Society to see if the Reading Centre qualifies and if so to request a couple of detectors for loan out to residents to test their homes. Chair Panio will also check with the Lung Association.

Hi Jeanne,

The Riondel Commission of Management has received correspondence from residents of our community expressing concern over the quality of cell phone service in our area. The concerns were largely regarding deficiencies in communication in the event of emergencies such as wildfires or highway accidents. Cell phone coverage is hit-or-miss in the Riondel area, and it would be a tragedy if poor communications was a determining factor in a situation involving residents and/or visitors. As you are aware, reliable communications are critical in rural areas such as ours.

As one correspondent phrased it, this is a "solvable risk." The Commissioners urge you to reach out to all cell service providers to try to encourage/promote/support the implementation of needed infrastructure guaranteeing reliable cell service in Riondel and along Riodel Road, ensuring effective communications of such things as evacuation alerts & orders and timely information from involved authorities.

Improved cell service would also be of considerable value to the many residents who must depend upon such a service for business dealings, communication with family, and making arrangements for medical and other appointments outside our community. Working in our Community Centre, I have seen many instances of the frustration users of the Centre experience when they're forced to look for an area outside of the building to find a usable signal.

It's also important to note that a significant percentage of Riondel residents no longer have land lines in their homes, and depend entirely on cell service for daily communications.

I know that you have been addressing these communication issues with the Regional Connectivity Committee across all or portions of five Regional Districts. We just want to add our voice to these discussions. Riondel has up to now been spared having to deal with the kinds of disaster scenarios faced by other communities in B.C. and across the country, but it would be comforting to know that we have a communications infrastructure in place here that would serve us all well if needed. And the average cell phone user would be grateful to be freed of the daily constraints of having to deal with communications "dead zones."

Thank you for your attention to these concerns. We hope there is a way forward that serves the best interests of all parties concerned.

The intent of this letter is to voice the concerns of the Riondel residents concerning the deteriorated condition of the Riondel Road. This includes the roadway from the junction with Highway 3A to Riondel including the Riondel streets, Fowler and Eastman Avenue.

The Riondel road is our only option into and out of Riondel.

These are our safety concerns:

- over the past several years the driving surface of our road has become dangerously narrow due to the deterioration of the paved shoulder.
- there is an ever increasing number of pot holes, frost heaves and broken pavement
- those walking or cycling have no safe space
- straddling or crossing the center line is often the safest option to avoid the narrow and uneven shoulders
- winter driving compounds these safety concerns when even the plow trucks are hesitate to venture far from the center of the road
- the south bound lanes of Fowler and Eastman are rapidly crumbing, likely due to the log trucks travelling through

Our Riondel road has been neglected and in need of major repairs for at least five years. The only road maintenance we see is the YRB crew hand shovelling cold mix into some pot holes and select shoulder areas, compaction of the cold mix is using the rear wheels of a dump truck.

The line marking contractor missed the Riondel road this year, perhaps because the driving surface is no longer wide enough to qualify as a two line highway.

When travelling on other Kootenay roads, we see major improvements to most of them.

Last year Shoreacres to Thrum's, most side roads and frontage roads were re-surfaced. All of Wadd's Road was seal coated. This year Balfour to Nelson was widened and re-surfaced. Almost all secondary and back roads were also repaved, Crawford Bay to Kuskanook was extensively repaired.

We hope you can address our concerns and we are requesting that MOT prioritize the Riondel Road for widening, straightening and paving for the safety of our residents.

The property will always be 1/9 ownership whether it's a sibling or a child of that sibling.

There is always the possibility that we lose Queen's Bay because we are on Crown Land.

Are there capital gains tax on a second property?

In Canada, you don't need to pay tax on the sale of your primary residence due to the residence exemption. However, secondary properties are considered taxable assets, which means that owners will be taxed for any property value increases upon the sale of the property, which also includes when the property is inherited. Properties considered as a secondary property can include cottages, second homes, vacant land, farm property or an investment property (rental or commercial).

When you sell a second property, you will be taxed on 50% of gains, which is also called in inclusion rate. You must report any capital gains or losses on Tax Form Schedule 3, the capital gains and losses form.

Capital gains tax must be paid before the property can be transferred to an individual.

The main way of avoiding paying capital gains tax on inherited property in Canada is to make that property into your primary residence.

What is the 21 year Rule Disposition.

Family trusts created during someone's lifetime are deemed to dispose of their property every 21 years. This will happen if we form a trust?

How much is land transfer tax in Canada.

- 1. Land Transfer Taxes are anywhere between 1% of the fair market value up to and including \$200,000 to 2% of the fair market value greater than \$200,000 and up to and including \$2,000,000 of property value 3% of the fair market value greater than \$2,000,000. It's the
- 2. buyer not the seller that pays the land transfer tax. Land transfer tax must be paid in full as a one-time payment.

Though potentially much smaller than the capital gains tax, the land transfer tax also known as a property transfer tax, is often overlooked as part of the overall cost of purchasing real estate. It comes into play when real estate is transferred for value (so if you gift a property to your children, it may not be applicable).

Even if you gift the property, you'll be deemed to have received fair market value for it, and you'll have to report the disposition of the property and pay the tax liability – even though you haven't actually received any money for the asset.

A capital gain refers to the difference between the cost of purchase and the fair market value of a capital asset, such as real estate.
