# SLOCAN PARK COMMUNITY HALL SOCIETY PRESENTATION TO REGIONAL RECREATION COMMISSION #8 – SEP 12, 2023

Good Evening and welcome to the Slocan Park Hall. My name is Lorraine Podovelnikoff and standing with me is Peter Cotter. Peter is the Chair of the Slocan Park Community Hall Society and I sit as the Secretary. This non profit Society was incorporated on May 23, 1978 and since that date, has overseen the day-to-day operations and management of the Slocan Park Hall. The Society currently has 8 Directors.

The origin of this Hall started as a one room schoolhouse in 1929 which was eventually closed in 1978. It was sold to Slocan Park Improvement District (SPID), who, in 1985 entered into a 99 year lease with Slocan Park Community Hall Society— this lease expires on November 1, 2085. Since the formation of this Society, there have been countless donations of time, effort and willingness on the part of everyone to continue keeping and using this space as a true recreation and community centre, overseen by elected Directors of the Society.

This Hall is rented for recreation programming, social functions, AGM's/meetings, educational classes and seniors' gatherings, just to name a few. As well, an office space is rented by RDCK for a part-time Recreation position which oversees Rec programming in our area. This relationship and arrangement have been in place for the last 30 years.

The outdoor space at this Hall, in particular, has significantly developed over the last several years and we are requesting ongoing funding from Recreation Commission # 8 budget to upkeep/maintain these outdoor amenities.

We have watched in awe as young families have mobilized and worked so hard to create a ballfield, ice rink and playground on the Hall site – an outdoor space that is now enjoyed by them, their children, parents and grandparents. The 3 amenities described below add immeasurable recreational, sporting and socialization value not only to the residents of Slocan Park, but to folks from the Slocan Valley and beyond.

# 1. Ballfield:

A fully developed fenced ballfield with underground irrigation system.
 The size meets the requirements for under 13 Little League baseball

- 80 players throughout the Slocan Valley and beyond registered for this ball program in 2023 – this is the 6<sup>th</sup> year since baseball started
- Built and managed by Slocan Valley Baseball Association many volunteers run this program and maintain the field
- Practices and games use this field 4 times per week during ball season – April, May, June. There were 3 additional ball camps this summer and Fall ball is also scheduled for September/October
- Families use this "green" space off season or in between practices open for public use
- Equipment storage is in Hall basement no fee charged for this or for field usage.

# 2. Ice Rink:

- This rink has been active for the last 2 seasons
- All infrastructure is in place to support an ice rink. There is even, compacted ground, an ice rink liner, outdoor evening lighting and perfect location
- Water source is close to the rink
- Have snowblower to plow out pathways
- Built, flooded, maintained, shovelled, and disassembled by volunteers
- Equipment storage is in Hall basement no fee charged for this or for field usage
- There is annual damage to grass and irrigation system on baseball field once rink is dismantled
- Very popular with many kids/youth/adults and used evening and daytime hours in winter.

# 3. Playground:

CSA certified playground was built in 2018

- Encourages play and socialization for children ages 5 to 12 years of age
- The playground lends to the feel of a park-like setting and draws children from the ball program, recreation programs offered at Hall, and the public in general
- Has been instrumental in providing a safe, outdoor "community meeting place". Used by many families.

# Annualized Funding Request for Minor Playground Maintenance Costs: \$200

All three amenities have been built as a direct result of community requests – our demographics are changing and younger families have moved to this area, often from larger centres where these types of services are readily available. Our kids, families and seniors deserve a place to gather, socialize, have fun, play sports, etc. and in a manner that is within their geographical and economic reach.

We now need to maintain these amenities for future use and feel our volunteers need some respite too! We respectfully ask Recreation Commission #8 to consider our request for ongoing annualized funding of \$7,170.

In closing, I'd like to share comments from an email recently sent to me by Annabelle Piche, Head Recreation and Fitness Leader of Slocan Valley Recreation:

"The Slocan Park Community Hall is our base office in the Slocan Valley. It allows us to offer quality activities in a beautiful setting. This summer, the camps with the highest registration numbers were at this location. Kids were able to run around the baseball field, use the playground (which they did a LOT) and go inside to enjoy cooler temperatures when needed. Booking is easy to do thanks to our contact at the hall and any help that we need is always supported by the Board.

Supporting the ice rink, ballfield and playground would make a huge difference not only for the hall, but also for us. We are still developing programming and showing the community that even though our activities are short in term and variety, we support other organizations in their programming. This could even

become a potential partnership. We are lucky to be able to call this Hall our office."

# **SECTION 1: EXECUTIVE SUMMARY**

The purpose of this report is to provide an update on the various program service areas within the Slocan & Valley region.

# **SECTION 2: BACKGROUND/ANALYSIS**

# 2.1 Regional Programming - General

The programming stats are presented below for the months of January to June and Summer of 2023 with a comparison from 2019. This is the first year a large amount of similar data has been collected for all of the recreation facilities, analyzed independently, and compared to each facility.

Starting in Q4, for 2023 programming updates, stats will be compared to the previous year (2022), as opposed to 2019. Comparing operations to a previous year post-pandemic will be more reflective of the more current planning and targets set to programming strategies.

In parallel to working on the programming plan for 2024, the Programming team is currently working on a programming strategy that will outline programming priorities, goals, and implementation for RDCK Programming. With the use of guiding documents (Recreation Framework, Master Plans, etc), the team will be able to clearly outline what the goals of programming are, why it's important, and how the goals will be achieved. Some of the changes to current practices that will come out of this strategy will include:

- Alignment with guiding best practices
- Continuity and consistency within the services
- Data collection, evaluation, and reporting

The strategy will be shared with the Committees and Commissions once completed.

#### 2.2 Regional Programming - Local

The new Head Rec & Fitness Leader, Annabelle Piché, started this past Spring, re-opening the Recreation Office at Slocan Park Hall. Annabelle comes with experience in Recreation and has been a valuable resource for not only the community, but also the Programming Team as she has been building connections with potential instructors as well as providing a local voice to what opportunities exist in the Valley.

The Regional Programming Team toured the Slocan Valley on May 26 with Annabelle and Joe Chirico to better understand the indoor and park spaces available for programming as well as a better understanding of the proximity of the communities to one another. They toured from the junction to New Denver in hopes to begin offering more recreation opportunities in this area in 2024.
