### ELECTOR REGISTRATION

**If you are not on the list of electors**, you may register at the time of voting by completing the required application form available at the voting place. To register you must meet the following qualifications:

- 18 years of age or older on general voting day;
- Canadian citizen;
- resident of BC for at least 6 months immediately preceding the day of registration;
- resident of OR registered owner of real property in the RDCK for at least 30 days immediately preceding the day of registration; and

- not disqualified under the *Local Government Act (LGA)* or any other enactment from voting in an election or otherwise disqualified by law.

**To register, resident electors** must produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

**To register, non-resident property electors** must produce **2 pieces of identification** (at least one with a signature) to prove identity, **proof** that they are entitled to register in relation to the property, and, if there is more than one owner of the property, **written consent** from the other property owners. (Consent form may be downloaded from the RDCK website at [www.rdck.ca](http://www.rdck.ca).)

Pursuant to the *LGA*, no corporation is entitled to be registered as an elector or have a representative registered as an elector and no corporation is entitled to vote.

### VOTING BY MAIL

The RDCK has enacted a bylaw which authorizes voting by mail ballot and establishes the procedures therefor. The only electors who may vote by mail ballot are the following:

- persons who have a physical disability, illness, or injury that affects their ability to vote at an other voting opportunity; and
- persons who expect to be absent from the RDCK on the General and Advance Voting Days.

Qualified electors wishing to receive a Mail Ballot Package must apply to the **RDCK** before **October 18, 2018 at 4:00 p.m.** Ballots must be returned to the voting station at the RDCK at Box 590, 202 Lakeside Drive, Nelson, BC by **8:00 p.m., Saturday, October 20, 2018.**
