CALL TO ORDER

At 6:04 p.m., Chair Rotvold called the meeting to order.

She welcomed Kaslo and area residents to the meeting.

She thanked the Directors for attending the facility tour in Kaslo and expressed her appreciation to Interior Health staff for conducting the tour.

Todd Mastel introduced Pat Dooley to the assembly. Mrs. Dooley is the Interior Health Board member for the West Kootenay-Boundary region. Mrs. Dooley grew up in Kaslo.

DELEGATION: Kaslo and Area Medical Care Society

James Morris, President of the Kaslo and Area Medical Care Society addressed the Board at 6:10 p.m.

Mr. Morris said the Society has over 300 members. The group is concerned about service erosion at the Victorian Community Health Centre and that residents do not have access to the emergency and clinical services they deserve. The Society is trying to restore 24/7 emergency care by establishing an independent clinic with one or two physicians. The Society is exploring funding opportunities to establish the clinic and recruit physicians.

Chair Rotvold thanked Mr. Morris for his presentation and encouraged the Society to work with Interior Health on health care issues in Kaslo.

DELEGATION: Interior Health Authority

At 6:26 p.m., Todd Mastel announced that Interior Health has a new President and Chief Executive Officer—Mr. Chris Mazurkewich.

Mr. Mastel then presented IH's 2014—2015 Global Grant list, which shows the projects the WKBRHD and IH have jointly funded.

Mr. Mastel and Cheryl Whittleton gave a PowerPoint presentation on health care service planning.

Firstly, Mr. Mastel clarified what Interior Health is responsible for: Hospital/acute care; residential/community care; prevention and health promotion; off reserve First Nations health; emergency preparedness; drinking water protection; and child care licensing. The Authority is not responsible for ambulance, fee for service payments to physicians, public transit or housing.

He pointed out pressures on the health care system and its resources, namely, mental health and substance use, cancer, frail-in-care and end of life. An aging population will continue to put pressures on the system.

Mr. Mastel said chronic disease rates in the West Kootenay-Boundary are consistent with other regions.

The Ministry of Health is moving toward greater community care, which would mean keeping people at home as much and for as long as possible. To that end, the Ministry has released a number of policy documents over the past two years regarding health care prioritization, patient-centred care, rural health services and primary and community care.

The Ministry's goal is to improve access to and design services for primary, residential, and home and community care for those with high health/support needs. Another priority is to "improve timely access to appropriate surgical treatments and procedures." The Ministry is also focusing on quality health care in rural and remote areas.

Ms. Whittleton talked about the approaches IH plans to take to effect these changes.
