





Kokanee Creek Nature Centre Activity Report 2023

Kokanee Creek Nature Centre Activity Report – 2023

Abstract

We opened from May 18 to September 24 and operated 15 programs, welcomed over 22,600 visitors to the nature centre, and 3,000 participants to our programs. We employed eight naturalists and visitor centre staff and updated two displays- the climate change display and the wildlife taxidermy display.

We also worked in partnership with the Kokanee School Programs to offer programs to 36 school groups (a total of 2017 youth, teachers, and parents). The Channel Guardian Program (a partnership with BC Parks and BCCF) employed 11 naturalists and compliance staff to monitor visitor behaviour on the spawning channel after August 9 when the Kokanee Salmon returned. We hosted approximately 12,000 visitors to the channel during the spawning season and engaged 2,800 of those in conversation.

This report gives more details about our successful season. We are looking forward to 2024!

Introduction

The Kokanee Creek Nature Centre is located in Kokanee Creek Provincial Park, about 20km from Nelson and 10km to Balfour B.C.

The Nature Centre is operated by the Kokanee Creek Nature Centre Society, a non-profit organization that offers professional outdoor educational programs in the park. We operate under the "teach the teacher" model where we mentor the naturalists and staff who work in the centre and offer them the opportunity to develop skills and work experience.

In 2023, a major funder, the CBT (Columbia Basin Trust), stopped funding outdoor education leaving the society with a substantial shortfall at the beginning of the season. The Friends of West Kootenay Parks stepped up and approached local businesses and



individuals to help us open and operate our programs. The Nelson and District Credit Union purchased a Kootenay Hellman canoe for us to raffle off. All of these efforts by our supporters were successful in providing the financial support we needed. It is also heartening to realize how many people care about this little nature centre in the woods.

We opened from May 18 to September 24 and operated 15 programs, welcomed over 22,600 visitors to the nature centre, and 3,000 participants to our programs.

The following document offers more details.

Programs and Activities

Program Attendance




Figure 1 We offered 15 programs to 3,000 people






Figure 2- Programs and Participants

During a successful 2023 season, we offered 15 in-house programs to 3017 participants from May 18 to September 24. (Fig 1, 2).

Our in-house programs included: Evening Naturalist Talks; Jerry's Rangers, Summer Guest Speaker Series; Storytellers; Naturalist Walks, Fish Dissections, Popup Displays, Art in the Park and Nature's Notebook; Stick Making, Rainy Day Movies, Story and Song; Survivor Skills; Kokanee Nature Investigators; and Botany Walks. Programs are described below.

We also worked in partnership with the Kokanee School Programs to offer programs to 36 school groups a total of 2,017 youth, teachers, and parents). The Channel Guardian Program (a partnership with BC Parks and BCCF) employed 11 naturalists and compliance staff to monitor visitor behaviour on the spawning channel after August 9 to September 25. We hosted approximately 12,500 visitors to the channel during the spawning season.

Our Summer Speaker Series welcomed eleven guest speakers to speak to 438 guests. Talks covered a variety of topics from history and culture to wildlife biology and geology (Fig 4).

Nelson storytellers continued their decades long support for the nature centre by offering tales every Saturday night in July and August to 255 people.




Figure 5 Evening Naturalist Talks






Figure 8 Survival Skills and Art in the Park and Sponsors



Instructor N. Jelfs instructed thirty-six young people from 9-12 years old in our survivor skills program. Participants learned how to set up survival structures, light a fire effectively, use a map and compass and how to behave if lost in the woods (Fig 8).


Our artist in residence R. Watt-Osecki, offered Drawing in Nature and Nature's Notebook to 111 visitors of all ages. Participants could make their own nature notebooks and enjoy learning drawing techniques while drawing in the forest (Fig 8).

Botanist U. Lowrey led three botany walks to 13 people on the park trails.

Projects

Climate Change Display

L. Murray took the lead in updating our climate change display this summer (Fig. 9).



The display now shows the loss of ice mass by Kokanee Glacier from 1925 to 2010 and then 2022. Included in the display are current projections of how the current interior wetland ecotypes of Kokanee Creek will change in the future – to those climate conditions most closely resembling the current dry ecosystems of the Okanagan.

Wildlife of Kokanee Creek Taxidermic Display

We continued to update the wildlife species display in the centre by adding a taxidermic flying squirrel, ruffed grouse, Barred Owl, and Great Horned Owl (Fig 10). A picture key to the animals helps visitors identify the different species in the display.

Trail Cam and GoPro Videos

We have posted over 400 wildlife and Kokanee Salmon videos on our Vimeo.com page (https://vimeo.com/kokaneecreeknaturecentre). These videos are free to download and are ad free. Nelson and Kootenay Lake Tourism sponsored the purchase of a GoPro in the spawning channel (with the permission of BC Fisheries and BC Parks) this season (Fig 11). The videos are extremely popular with the public.

All these amazing videos of the Kokanee Salmon, bears, American Dippers and Common Mergansers in the channel and the bears, deer, moose, beavers, and other wildlife are played on the big screens in the atrium and the discovery room in the Nature Centre. The videos and photos are also shared on Facebook (https://www.facebook.com/KokaneeCreekNatureCentre/) (Fig 11). Our videos have attracted almost 40,000 views on Vimeo and 3,535 Facebook followers. We have shared the videos with B.C. Fisheries, Selkirk College, the Sinixit and others interested



in the behaviour and biology of the Kokanee Salmon.

Partnerships

Kokanee Salmon School Program

We again worked in partnership with the Kokanee Salmon School Programs to offer programs to 36 school groups (a total of 2,017 youth, teachers, and parents) in the Nature Centre Suzy Hamilton Theatre and on the spawning channel.

Malaise traps

The University of Guelph placed two insect traps (Malaise traps) in the park. This is part of a national initiative to monitor changes in the insect populations over time. Kokanee Creek Naturalists participated by putting up educational signs near the traps

and by collecting the samples biweekly (Fig 12).

Channel Guardians

The Channel Guardian Program (a partnership with BC Parks and BCCF) employed 11 naturalists and compliance staff to monitor visitor behaviour on the spawning channel after August 9 when the Kokanee Salmon returned. We hosted approximately 12,400 visitors to the channel during the spawning season and engaged 3,000 people in conversations about the fish, bears and the park.

SECTION 1: EXECUTIVE SUMMARY

The RDCK holds a "Public Trail" License for the Nelson-Salmo Great Northern Trail with BC Transportation and Financing Authority which has been in place since 2006, and expires December 31, 2025 (Attachment A). The RDCK Parks Service desires a management plan for a multi-use trail that will guide effective management as well as the renewal of the License. The purpose of this report is to outline how this can be accomplished.

SECTION 2: BACKGROUND/ANALYSIS

Background

The Nelson-Salmo Great Northern Trail (GNT) covers approximately 48 km between the Village of Salmo and the City of Nelson. The rail corridor itself consists of 28 parcels of land in fee simple, owned by BC Transportation and Financing Authority (BCTFA). In order to develop the corridor for recreational trail use, the properties are licensed to the Regional District of Central Kootenay (RDCK), which manages and administers the facility as a regional trail. BCTFA, as the legal owner is responsible for the infrastructure, such as trestles, public road crossings, and culverts. License holder improvements, such as parking lots, viewpoints, picnic areas, and their associated facilities are the responsibility of the RDCK. The following is a brief history of the GNT:

Management Plan

Through management planning goals, objectives and policies of the trail area set to guide ongoing development and management strategies. The current Management Plan for the trail was completed in 2003. An updated

management plan is required to provide direction for decision making over the next 15-20 years. Management planning processes are designed to engage First nations and include public consultation and stakeholder outreach. The following information is intended to provide an initial outline of what we know about the GNT and what a management planning process could look like if work is undertaken over the next two years.

Initial Assumptions

- Visitors frequent the trail for a wide range of activities from walking to off road vehicle (ORV) use.
- Appropriate locations and management practices for mixed use trail activity will need to be considered.
- Mixed use means consideration of suitable motorized and non-motorized activities.
- All mixed use trail activities will be studied in a fair and equitable way.
- There is a need to establish a current understanding of trail use and activity trends.
- Engagement will occur with First Nations, resident and stakeholders
- We need to understand and consider a wide range of perspectives to identify current and future needs.
- We need to understand the willingness to pay for the preferred implementation strategies.

Initial Goals

- Avoid segregating or stigmatizing any users.
- Protect sensitive habitat and natural environments along the corridor.
- Protect archeological and culturally significant sites along the corridor.
- Preserve and protect agricultural values along the corridor.
- Prevent vandalism, garbage, noise, & unwanted use for adjacent property owners.
- Provide best practices and options for motorized and human powered activity use.
- Provide options for access control and safety for trail users.
- Identify connections to local community amenities, destinations, water access and routes.
- Establish standards for trail work and other infrastructure (i.e road crossings, signage, culverts, bridge and trestle, trailheads, safety barriers).

Management Planning Process & General Tasks

The management plan will include strategic direction (park vision, goals, and management statements relating to the Scope of Work (Table 2), as well as, park zoning, a development concept, key management actions and a general implementation strategy. The general tasks to achieve this include:

- 1. Gather background information and conduct site visits.
- 2. Liaise with key stakeholder and governments and provide opportunities for public engagement.
- 3. Assess input received and develop a draft Plan.
- 4. Public review/engagement of draft Plan.
- 5. Analyze comments and finalize Plan.
- 6. Provide a recommendation to the Commission and RDCK Board for approval.

Proposed Timeline

The project will occur over two years as shown in Table 1. The initial proceedings in 2024 are intended to prepare for the formal management planning process in 2025. It will not be until 2025 when the formal management planning process begins, including consultation and engagement.

3.2 Legislative Considerations (Applicable Policies and/or Bylaws):

There would be a need to review the ORV act and other mechanisms in order to determine the appropriate framework for ORV use.

3.3 Environmental Considerations

The Nelson-Salmo Great Northern Trail both crosses and parallels significant watersheds. Throughout its length the trail bisects land that are home to grizzly and black bears, moose, elk and deer and other terrestrial vertebrates. Riparian and wetland habitats are used by migratory birds.

3.4 Social Considerations:

The safety to trail users is the paramount concern and should continue to be improved to ensure users of all sorts have a sage and enjoyable experience.

3.5 Economic Considerations:

Rail trail tourism is thought to be a significant economic generator. The RDCK has not done an economic impact study to understand the full impacts.

3.6 Communication Considerations:

It will not be until 2025 until the project commences with a project webpage, public awareness information, digital tools, and initial input survey are in place.

Prior to commencing the project we reached out to Greg Kinnear, District Manager of the MOTI West Kootenay District and there is support for moving forward with a Management Plan.

3.7 Staffing/Departmental Workplan Considerations:

At current Parks Service staffing levels the project may be delayed by other projects.

3.8 Board Strategic Plan/Priorities Considerations:

This work would align with the following strategies and desired results in the Board's 2019-2023 Strategic Plan:

- Modernize the RDCK policy framework. All RDCK policy is innovative, reflects best practices, and considers unique RDCK requirements.
- Manage taxation by responding to residents' needs and appropriately prioritizing projects. Long-term cost impacts are evaluated for any new initiatives or infrastructure being considered.

SECTION 4: OPTIONS & PROS / CONS

Options

- 1. That the Commission directs staff to prepare a Management Plan for the Nelson-Salmo Great Northern Rail Trail.
- 2. That the Commission takes no further action with regard to a Management Plan for the Nelson-Salmo Great Northern Rail Trail.

Pros

- Phasing the project over two years allows staff to complete the project
- The Management Plan will guide effective management as well as the renewal of the License.

Cons

- Phasing the project over two years means that public consultation will not occur until 2025.
- At current staff levels the project may be delayed by other projects.

SECTION 5: RECOMMENDATIONS

That the Commission directs Staff to include \$15,000 in the 2024 Financial Plan for Service S202 to support the Initial Research Phase of a Management Plan for the Nelson-Salmo Great Northern Rail Trail.

AND The Parties acknowledge that the License Area is situated within the Regional District of Central Kootenay, from the Village of Salmo to Troup Junction within the Province of British Columbia, and has been reserved by the Province of British Columbia primarily for future transportation needs and also as a utility corridor;
- E. AND BCTFA desires to license the License Area to the Regional District of Central Kootenay for the purposes of constructing and maintaining a regional public trail for a period of Twenty (20) years and which is renewable for a further Twenty (20) years, unless terminated in accordance with the provisions herein.

IN CONSIDERATION of the covenants and agreements of the Licensee contained herein and other good and valuable consideration, BCTFA grants to the Licensee the contractual right to use and occupy the License Area for a term of twenty years ("Term") commencing January 1, 2006 ("Commencement Date") and expiring on December 31, 2025 ("Expiry Date") and in consideration of the sum of \$10 ("Fee"), now paid by the Licensee to BCTFA (the receipt and sufficiency which is acknowledged), of the rights granted by BCTFA to the Licensee herein and other good and valuable consideration, the Licensee covenants and agrees with BCTFA to only use and occupy the License Area in accordance with the following terms and conditions:

1. Use and Risk

1.1 Permitted Use

The Licensee shall use the License Area for the Term, or any extension hereunder, only for the purposes of construction, operation, use, maintenance, repair, removal and replacement of a regional public trail within a linear corridor (together, "Permitted Uses") and for no other purpose unless agreed to in writing by BCTFA (in BCTFA's sole discretion), subject always to the terms and conditions contained herein. In connection with the Permitted Uses, the Licensee may permit uses outlined in the Management Plan as amended from time to time and approved by the BCTFA, attached hereto as Schedule "C" ("Management Plan") which uses shall include but are not limited to pedestrian, horse and bicycle access on the License Area. The Licensee shall not use the License Area, or permit the License Area to be used, for any commercial or profit purpose without the prior written consent of BCTFA, which consent may be arbitrarily withheld without giving any reason therefor.

1.2 Risk

The Licensee's use and enjoyment of the License Area will be at the Licensee's sole risk, cost and expense unless otherwise expressly provided herein.

1.3 Representations and Warranties

The Licensee warrants and represents to BCTFA, with the knowledge that BCTFA will rely on these warranties and representations in entering into this Licence, that the Licensee is now aware of and acknowledges it is satisfied as to:

(a) (i) the fitness of the License Area for the Permitted Uses; and

- (ii) the general condition and presence of any utilities or other systems on or under the License Area; and
- (b) it forever releases BCTFA from any and all claims relating to any of the matters set out in section 1.3(a) above.

1.4 Licensee's Acknowledgement

The Licensee acknowledges and agrees with BCTFA that the Licensee:

- (a) has inspected the License Area and fully accepts the License Area in the condition and state in which it was found on the date of that inspection;
- (b) has conducted an investigation of the condition, environmental or otherwise, of the License Area;
- (c) the License Area is being licensed to it on an "as is, where is" basis;
- (d) in entering into this License, the Licensee has not, except as otherwise specifically set out herein, relied on any warranty or representation given by or on behalf of BCTFA concerning any of the matters set out in section 1.3(a) above or the applicability or otherwise to the License Area of any federal, provincial or municipal statute, bylaw, regulation or law;
- (e) will, during the Term, assume liability for any Hazardous Materials or potentially dangerous substances or conditions installed on, brought or caused by:
 - (i) the Licensee; or
 - (ii) any of the Licensee's servants, agents, employees, contractors, subcontractors, trades, and invitees, including members of the general public using the License Area for trail purposes, ("Licensee's Representatives") and will share the liability equally with BCTFA for Hazardous Materials brought onto the License Area by members of the general public.

- (h) it is aware that this License and any information regarding this License or the Licensee may be disclosed or may be required to be disclosed pursuant to the Freedom of Information and Protection of Privacy Act, (B.C.), governmental policy or otherwise.

2.1 Renewal

Unless terminated by BCTFA or the Licensee, in accordance with the terms of this License, and so long as the Licensed Area is not or will not be within a reasonable time thereafter, required for transportation purposes, the Licensee may upon 180 days' written notice to BCTFA prior to the Expiry Date, renew this License for a further 20-year period.

2.2 Early Termination

- (a) BCTFA may terminate this License and the Term (or any extension thereof), if the License Area is, or will be within a reasonable time thereafter, required for transportation purposes, by giving the Licensee one (1) year prior written notice of termination at any time before, on or after the Expiry Date, in which case the Term will expire effective at 5:00 p.m. on the date which is one (1) year after such notice.
- (b) The Licensee may terminate this License by giving BCTFA one (1) year notice in writing should the Licensee no longer require the Licensed Area for its Permitted Uses provided that upon such termination the Licensee shall leave the Licensed Area in a neat and tidy condition and remove from the Licensed Area any improvements built upon the Licensed Area if requested to do so by BCTFA.
- (c) The Licensee may terminate this Licence if the underlying structure of the Licence Area, namely the trail bed or the trestles are destroyed, damaged and unsafe for use as a recreational trail and BCTFA, upon notice in writing given by the Licensee has refused or failed to repair or replace the trail bed or trestles within the time specified within the notice or such longer period of time as BCTFA may deem reasonable, in which event the Licensee may terminate this Licence forthwith.

3. Licensee's Obligations

3.1 General Obligations

The Licensee will, at its sole cost and expense, during the Term or any extension thereof:

(a) repair, maintain, keep and replace the License Area in good order and repair as a careful owner would do with respect to the operation and maintenance of a recreational trail except for such repair, maintenance and replacement which BCTFA agrees to have performed by a third party in BCTFA's sole discretion from time to time. For the purposes of clarification of this obligation, the Licensee shall be responsible for repair, maintenance, keeping and replacing the trail surface of the Licence Area and BCTFA shall be responsible for the repair, maintenance, keeping and replacement of the trail bed, including the trestles, but BCTFA will not be required to replace trestles or portions of the trail bed washed out or obliterated by a flood or landslide or otherwise significantly 1 57 1 47

damaged or destroyed, but would instead use commercially reasonable efforts to provide the Licensee with an alternate route for the Licensee's use under this Licence;

- (b) not construct or cause to be constructed, placed or installed any building, improvement or structure of a permanent nature, and excluding improvements of a non-permanent nature which are required for the use and enjoyment of the License Area for the Permitted Uses, on all or any part of the License Area at any time until plans, specifications and construction schedule therefor have been provided to and approved by BCTFA in writing, in BCTFA's sole discretion, and the Licensee has obtained all required municipal or governmental approvals and permits, all at the Licensee's sole cost and expense. BCTFA will not be required to review or approve any such plans, specifications and schedules if BCTFA determines, in its sole discretion, that the alteration or work described therein may in any way lead to a contravention of any other provision herein;
- (c) not do or permit anything to be done which damages any of the License Area, except as shown on the Management Plan approved under section 3.1(b) by BCTFA, or which damages or interferes with any improvement on, in or under the License Area (including any pipeline, utility or facility), or the subsurface thereof or the subsoil structure thereof, or which would prevent or impede BCTFA or its successors in title from developing the License Area in the future for road or highway purposes;
- (d) use its best efforts to preserve and protect the natural environment in the License Area save and except the areas necessary to be cleared for trail usage ("Trail Surfaces") and save and except as shown on the Management Plan approved under section 3.1(b) by BCTFA;
- (e) be responsible for drainage off the trail surface of the License Area;
- (f) not to cut down merchantable timber without the written approval of BCTFA;
- (g) maintain the License Area free and clear of any lien, certificate, judgment, charge or encumbrance (together, "Charge") of any nature whatsoever in relation to the use of the License Area by the Licensee or any of the Licensee's Representatives (including claims of the contractors or trades of the Licensee) to be imposed or to remain on all or any part of the License Area. If any Charge so exists, the Licensee will immediately cause the same to be discharged, failing which, BCTFA will be at liberty to pay and discharge any such Charge on giving the Licensee five business days' written notice of its intention so to do. Any amount so paid, together with any disbursements and costs incurred by BCTFA (including legal costs on a solicitor and own client basis) will become due and payable by the Licensee to BCTFA immediately on demand. The Licensee shall not be responsible for any Charge resulting from the activities of BCTFA or third parties who are not Licensee's Representatives or are not under the control of the Licensee;
- (h) when determined by BCTFA in BCTFA's discretion, acting reasonably, to be necessary for the protection of the public or users of the License Area, secure the whole or parts of the License Area and any improvement thereon in accordance with the requirements determined by BCTFA, acting reasonably, from time to time;

- (i) permit BCTFA, or any person or persons designated by BCTFA from time to time, free access to all parts of the License Area from time to time and at all times to enter and examine the state of repair and order of the License Area and to determine the Licensee's compliance with the provisions hereof, and BCTFA may give notice to the Licensee requiring that the Licensee perform such maintenance, repairs or replacements as may be found necessary from such examination;
- (j) comply with all laws, bylaws, rules and regulations of every municipal, provincial or federal governmental or other authority which affect the Licensee, its use and occupation of the License Area or this License;
- (k) not, in the exercise of any of the Licensee's rights under this License, cause any interruption of utilities or other services to, on, under or about the License Area or unduly interfere with BCTFA's (or its invitees or licensees) use of all or any part of the Licensed Area;
- do anything BCTFA may request from time to time to enforce compliance with any of the covenants, obligations or agreements herein on the part of the Licensee to be fulfilled, observed or performed ("Licensee's Obligations"); and
- (m) from time to time and at all times, promptly execute and deliver all such documents and assurances and do all such other acts and things as BCTFA may reasonably request in order to better evidence or perfect any provisions of this License or any of the obligations intended to be created hereby or thereby.

3.2 Environmental Obligations

(a) In this License:

(i) "Hazardous Materials" means:

- (A) any oil, flammable substances, explosives, radioactive materials, hazardous wastes or substances, toxic wastes or substances or any other wastes, or pollutants which pose a hazard to all or any part of the License Area, or any person, business or occupant or user of the License Area; or cause all or any part of the License Area or any user or occupant of the License Area to be in violation of any Hazardous Materials Laws;
- (B) asbestos in any form which is or could become friable, urea formaldehyde foam insulation or transformers;
- (C) any chemical, material or substance defined as or included in the definition of "dangerous goods", "deleterious substance", "extremely hazardous wastes", "restricted hazardous waste", "toxic substances", "waste" or words of similar import under any applicable local, provincial or federal law or under the regulations adopted or publications promulgated pursuant thereto;

- (ii) "Hazardous Materials Claims" means any and all enforcement, cleanup, removal, remedial, or other governmental or regulatory actions instituted or contemplated pursuant to any Hazardous Materials Laws; and
- (iii)"Hazardous Materials Laws" means any local, provincial or federal laws, rules, ordinances, regulations, orders or other edicts having the force of law relating to the environment or any Hazardous Materials or the environmental conditions on, under or about the License Area including, without limitation, soil, groundwater, and indoor and ambient air conditions.
- (b) During the Term, the Licensee will, at its sole cost and expense:
 - (i) comply with all Hazardous Materials Laws;
 - (ii) not deposit or release or permit any Licensee's Representatives to deposit or release any Hazardous Materials on, under, about or from the License Area;
 - (iii)not store or permit to be stored on or in the License Area anything that is of a dangerous, hazardous, inflammable or explosive nature or anything that would have the effect of increasing insurance costs or leading to the cancellation of any insurance with respect to the License Area;
 - (iv)after the commencement of the Term, and immediately on being made aware, notify BCTFA in writing, of the existence of any Hazardous Materials Claim or any Hazardous Materials on the License Area, or any discharges, emissions, or spill of Hazardous Materials on, under, about or from the License Area; and
 - (v) promptly provide BCTFA with copies of all notices issued pursuant to any Hazardous Materials Laws and evidence the Licensee is responding to such notices in a responsible manner if they concern matters which are the responsibility or obligation of the Licensee hereunder.
- (c) The Licensee will be liable for any and all costs (including all legal costs on a solicitor and own client basis) directly or indirectly arising out of or attributable to the presence of Hazardous Materials deposited or released by the Licensee or any of the Licensee's Representatives on, under, about or from the License Area;
- (d) Notwithstanding anything to the contrary contained in this License, the Licensee must, at its sole expense within 20 days of the expiry of the Term or any earlier termination of this License, remove any and all Hazardous Materials from the License Area deposited or released by the Licensee or any of the Licensee's Representatives and immediately repair, at the Licensee's expense, all damage to the License Area caused by such removal. If the Licensee fails to do so, then BCTFA may cause such removal and repairs to be undertaken and section 6.2 below.

3.3 Costs and Expenses

The Licensee shall be responsible for (and shall pay to BCTFA immediately on request without any set off, compensation or deduction whatsoever) all costs and expenses directly or indirectly relating to this License, the use of the License Area by the Licensee and any other matter contemplated herein, including but not limited to:

- (a) all taxes imposed as a result of the Licensee's license under this License, the License
 Area and on all machinery, equipment, improvements and fixtures placed on the Lands or
 used by the Licensee to the appropriate municipal, regional, provincial or federal taxing
 authority;
- (b) all sales, goods and services and other taxes imposed on BCTFA from time to time with respect to any matter under this License, including all applicable goods and services taxes on the Fee, unless the Licensee provides evidence satisfactory to BCTFA showing that the Licensee is exempt from payment of any such taxes; and
- (c) costs and expenses incurred by BCTFA (including legal costs on a solicitor and own client basis but not the costs excluded in parentheses in section 5.2 hereof) directly or indirectly relating to or arising from the exercise of the Licensee's rights hereunder or any default of the Licensee hereunder, and the Licensee does indemnify and save harmless BCTFA, the Province and any of their respective directors, officers, ministers, employees, agents and servants (together and individually, "Provincial Representatives") with respect to the same.

3.4 Delivery of Possession on Expiry or Termination

At the expiry or any termination of the Term or this License for any reason, the Licensee will, at its sole cost and expense and without notice from or cost or damage to BCTFA, forthwith vacate the License Area, deliver up possession of the License Area to BCTFA in the condition that the License Area is required to be maintained under this License, remove from the License Area, with the prior written consent of BCTFA, any improvements or fixtures placed in or on the License Area by or at the request of the Licensee, repair any damage caused by any such removal and pay all monies payable or owing by the Licensee hereunder.

3.5 Absolute Obligations of Licensee

The covenants, agreements and obligations of the Licensee hereunder are absolute and unconditional and will all survive the expiry or any termination hereof.

- Third Party Rights and Highway Dedication
- 4.1 Rights and Interests of Third Parties

The Licensee acknowledges and agrees that:

(a) the Licensee's rights and this License are subject to the rights and interest of all persons who are not a party hereto with interest in all or any part of the License Area at any time and from time to time on or after the date of this License, including those described below in this section 4;

(b) such persons shall have access to and/or may do such other works, acts and things as may be permitted under their respective documents with respect to the License Area provided such works, acts and things do not materially and adversely impact the use of the License Area by the Licensee hereunder. If any such works, acts or things have such an material and adverse impact, then BCTFA will not permit the work, act or thing without the prior written consent of the Licensee, which consent will not be unreasonably withheld.

The Licensee shall have no liability or obligation to BCTFA for the acts or omissions of the third parties mentioned in sections 4.1(a) and (b) above or for any of the "other persons" referred to in section 4.2 hereof, or for users of the highways and private crossings referred to in sections 4.4 and 4.5 hereof.

4.2 Reservation in Favour of BCTFA

BCTFA reserves to itself and to the Province the right to issue permits to construct and access the Licensed Area, and permits to other persons for the purpose of installing in the License Area underground or above ground utility facilities; to have such access to the whole or any part of the License Area as may be reasonably required by such other persons to survey, construct, maintain, lay down, operate and replace such facilities; to temporarily close the whole or any part of the License Area for any such purpose where reasonably required and where no reasonable alternative exists. BCTFA will give the Licensee no less than 30 days notice of its intent to grant such permit and provide the Licensee an opportunity to consult with BCTFA as to the method of installation of such facilities, the timing of such installation, and the period of closure of any of the License Area required for such installation.

4.3 Restoration by Third Parties

BCTFA will require or cause to be required, in any permit issued under section 4.2 above, that the permittee thereunder promptly after installation or repair, restore the surface of the License Area and any improvements placed thereon by the Licensee to the same condition that the surface or improvement was in prior to the work upon the License Area by such permittee. Such permit shall also require its permittee to indemnify and save harmless both BCTFA and the Licensee from any and all loss, liabilities, claims, costs or expenses whatsoever resulting from or in connection with any of the installation, operation, maintenance and repair of its facility in the License Area and the occupation of the License Area by such facility.

4.4 Highway Dedication

The Licensee acknowledges that during the Term, for the purpose of the orderly development of such rural lands and/or municipalities containing the License Area, it may become necessary for BCTFA, the Province or a municipality to gazette, dedicate or otherwise acquire highways across or along the License Area. BCTFA will consult with the Licensee as to any planned or required acquisitions for highway purposes across the License Area and will use its reasonable efforts to have any new highway acquired across or along the License Area use as little of the License Area as reasonably possible.

4.5 Private Crossings

Private crossings across parts of the License Area as at the Commencement Date, providing access across the License Area. The Licensee shall permit such private crossings to continue during the Term provided no new private crossings shall be permitted after the Commencement Date except with the prior consultation with the Licensee.

5. Insurance and Indemnity

5.1 Insurance

The Licensee will place and maintain, at its sole cost and expense, in good standing for the Term or any extension thereof, insurance according to the insurance requirements described in Schedule "D" attached hereto and which forms an integral part hereof. The Licensee will, on request from BCTFA, provide BCTFA with evidence that such insurance is, at all times during the Term or any extension thereof, enforceable and in effect.

5.2 Indemnity

The Licensee shall at all times defend, indemnify, save harmless release and forever discharge BCTFA, the Province and the Provincial Representatives against any and all loss, liabilities, claims, costs or expenses whatsoever resulting from or in connection with any of the following (excluding those arising from the negligence of BCTFA or matters which are the responsibility of BCTFA hereunder):

- (a) execution hereof or any act or omission taken or maintained or the exercise of any rights arising under this License or the License Area by the Licensee or any of the Licensee's Representatives;
- (b) any act or omission of the Licensee or any of the Licensee's Representatives;
- (c) any breach, violation or non-performance of any of the Licensee's Obligations; or
- (d) any damage to property and any injury to any person(s), including death, arising from or occasioned by any act or omission of the Licensee or any of the Licensee's Representatives occurring in or on all or any part of the License Area;

including all legal costs on a solicitor and own client basis. The indemnification contained in this section and sections 3.3 and 6.3 herein will survive the expiry or any termination hereof, notwithstanding anything herein.

Suspension, Default and Remedies

6.1 Temporary Suspension

At any time BCTFA believes, in its sole discretion, that the Licensee's use or occupation of the License Area represents a potential or actual hazard to the public, BCTFA, the Province, any Provincial Representative or the License Area, then BCTFA may, without any liability

whatsoever, on at least three (3) business days notice (except in the case of any emergency, as determined by BCTFA, in which case no notice is required), suspend the rights granted to the Licensee hereunder (including access of the Licensee to the License Area) for any reasonable period of time determined by BCTFA, without abatement of any costs, expenses or other monies payable by the Licensee hereunder.

6.2 Default and Remedies

If the Licensee does not observe or perform any of the Licensee's Obligations after reasonable notice to do so given to the Licensee, or the Licensee becomes insolvent or bankrupt, then and in every such case, BCTFA will have the immediate right and option to do any of the following, all without further notice to the Licensee or resort to legal process and without BCTFA being liable to prosecution or becoming liable for any loss or damage, any statute or law to the contrary notwithstanding, without prejudice to, and under reserve of, all other rights, remedies and recourses of BCTFA hereunder, at law, in equity or otherwise:

- (a) make any repairs or observe and perform the Licensee's Obligations in respect of which the Licensee has failed to observe and perform, in which case the Licensee will repay BCTFA on demand for all costs and expenses in connection therewith or incidental thereto; or
- (b) suspend the rights granted to the Licensee hereunder for a stated period(s) of time and to terminate this License any time thereafter; or
- (c) terminate this License.

6.3 BCTFA's Costs

If at any time an action is brought by, for or on behalf of BCTFA for recovery of possession of the License Area, for the recovery of any amount due under this License or because of a breach by act or omission of any of the Licensee's Obligations, the Licensee will pay to BCTFA all costs and expenses incurred by BCTFA in the enforcement of its rights and remedies under this License or otherwise in connection with any default of the Licensee under this License, including legal costs on a solicitor and own client basis, and the Licensee does indemnify and save harmless BCTFA, the Province and the Provincial Representatives with respect to the same.

6.4 Interest on Late Payment

If the Licensee fails to pay any monies payable by it to BCTFA under this License promptly when due, then the Licensee will pay to BCTFA interest on any such unpaid monies at a rate of 5% per annum above the floating annual prime interest rate established by the bank designated by BCTFA from time to time as the reference rate such bank will use to determine rates of interest payable to the bank by borrowers of Canadian dollar loans in Canada. The Licensee shall pay such interest from the date on which such monies were due until actual receipt of payment of the unpaid monies and the interest due under this Licensee by BCTFA.

7. General Provisions

7.1 Notices

Any notice or other instruments given hereunder to the Licensee will be delivered and addressed to the Licensee at its address shown below or at such other address as the Licensee designates in writing to BCTFA. Any such notice or instrument is exclusively deemed to have been given or made on the day on which it is delivered.

7.2 BCTFA Representative

The Licensee acknowledges and agrees that BCTFA appoints the District Manager, Kootenay District, Transportation (Ministry of Transportation) as its local representative for the License Area for the purposes of this License, and such representative (or any replacement appointed by BCTFA from time to time) will be the person whom the Licensee will deal with in regards to this License.

7.3 Waiver

Waiver of any default of the Licensee by BCTFA will not be deemed to be a waiver of any subsequent default of the Licensee by BCTFA.

7.4 Time

Time shall be of the essence of this License.

7.5 Contractual Rights Only

The Licensee acknowledges that the rights granted by this License are contractual rights only and do not create or grant to the Licensee any interest in land. Neither the Licensee, nor anyone on its behalf, will register this License or any notice or assignment hereof or any other document evidencing any interest herein against the whole or any part of the License Area.

7.6 Assignment by Licensee

Except as otherwise expressly provided for in this section 7.6, the Licensee will not assign this License (whether by mortgage, transfer, sale of its shares if the Licensee is a corporation, or otherwise) or otherwise part or permit any parting with possession of all or any part of the License Area or grant or permit the granting of any concession, licence or other right to all or any part of the Licensee Area. The Licensee may grant a sublicense of part, but not all, of the Licensee Area only with the prior written consent of BCTFA. If the Licensee intends to grant such a sublicense, it will give prior written notice to BCTFA of such intent, specifying the identity of the proposed sublicensee and providing such additional information as may be requested by BCTFA and if BCTFA consents thereto, in BCTFA's sole discretion, the Licensee shall be jointly and severally liable with such sublicensee on this License and the Licensee shall not be released from performing any of its covenants, obligations or agreements hereunder.

7.7. Assignment by BCTFA

BCTFA may assign this License or any or all interest in the License Area as BCTFA determines, in its sole and absolute discretion, and to the extent such assignee has assumed the covenants, obligations and agreements of BCTFA under this License, then BCTFA will, without further written agreement, be freed and relieved of all liability on such covenants, obligations and agreements. The Licensee will, from time to time at the request of BCTFA, certify or acknowledge to any purchaser or assignee, or proposed purchaser or assignee, the status and validity of this License.

7.8 Entire Agreement

This License and all documents entered into or granted hereunder set out all the covenants, agreements and understandings between BCTFA and the Licensee concerning the License Area and the Licensee's rights with respect thereto and may only be amended by written agreement duly executed by BCTFA and the Licensee.

7.9 Enurement

Notwithstanding anything herein, this License has no effect unless and until it has been executed and delivered by the Licensee to BCTFA, and BCTFA has approved it in writing and delivered a copy of such approval to the Licensee at the Licensee's address set out below.


