#### **REGIONAL DISTRICT OF CENTRAL KOOTENAY**

# Bylaw No. 2855

A bylaw to repeal and replace the RDCK Bylaw Enforcement Notice and Dispute Adjudication System Bylaw No. 2441, 2015.

WHEREAS the Regional District may implement a fine system bylaw.

NOW THEREFORE the Board of the Regional District of Central Kootenay, in open meeting assembled, enacts as follows:

#### **DEFINITIONS**

1 In this bylaw, unless the context otherwise requires:

Act means the Local Government Bylaw Enforcement Act and amendments hereto;

Bylaw Notice has the same meaning as in the Act;

**Early Payment** means an amount that reflects a discount deducted from the penalty as described in Section 6 of the *Act* and identified in Column A2 of Schedule A:

**Late Payment** means the amount due when a surcharge is added to the penalty as described in Section 6 of the *Act* and identified in Column A3 of Schedule A;

Notice of Penalty means a notice issued pursuant to Section 24 of the Act;

**Penalty** means the amount that the recipient is liable to pay in respect of a contravention of the related bylaw as identified in Column A1 of Schedule A;

Regional District means the Regional District of Central Kootenay;

**Registry** means the Regional District of Central Kootenay Bylaw Notice Dispute Adjudication Registry established pursuant to Part 8 of this Bylaw;

#### **TERMS**

The terms in the bylaw that are not defined in Section 1 have the same meaning as the terms defined in the *Act*.

#### BYLAW CONTRAVENTIONS

3 The bylaw contraventions designated in Schedule A attached hereto and forming part of this bylaw may be dealt with by Notice of Bylaw Violation.

#### **PENALTIES**

- 4 (1) The amount due for a bylaw contravention referred to in Section 3 is as follows:
  - (a) Subject to subsections (b) and (c) of this Bylaw, the corresponding amounts set out in Column A1 of Schedule A;

#### Discounted (Early) Payment Discount

(b) If payment of the penalty is received by the Regional District within 14 days of the person receiving or being presumed to have received the bylaw notice, the Discounted (Early) Payment Penalty set out in Column A2 of Schedule A applies;

#### **Late Payment Surcharge**

(c) If payment of the penalty is received by the Regional District more than 28 days after the person has received or presumed to have received the bylaw notice, the Late Payment Penalty set out in Column A3 of Schedule A applies;

#### Compliance Agreement

(d) If a compliance agreement is applicable, the Penalty percentage set out in Column A4 of Schedule A applies;

#### PERIOD FOR PAYING A DISPUTED NOTICE

- 5 (1) A person who receives a Bylaw Notice must, within 14 days of the date on which the person received or is presumed to have received the Bylaw Notice:
  - (a) Pay the applicable amount of the Discounted (Early) Payment Penalty established in Section 4(b) of this bylaw by completing the payment portion of the Bylaw Notice, indicating the Discounted (Early) Payment option and delivering, with payment in full of that amount, either in person during regular office hours or by mail to the Regional District office; or
  - (b) Request dispute adjudication of the Bylaw Notice by completing the form on the reverse side of the Bylaw Notice and delivering it either in person during regular office hours or by mail to the Regional District of Central Kootenay, P.O. Box 590, 202 Lakeside Drive, Nelson, BC, V1L 5R4.
  - (2) A person may pay the indicated penalty after 14 calendar days of receiving the notice, subject to the applicable surcharge for late payment in accordance with Section 4(c) of this bylaw but no person may dispute the notice after 14 calendar days of receiving the Bylaw Notice.

(3) In accordance with the requirements of Section 25 of the *Act*, if within 14 days of having received a subsequent notice from the Regional District indicating the amount owing pursuant to a Bylaw Notice that was not delivered personally, a person may advise the Regional District, in writing, that he or she did not receive the original Bylaw Notice and the time periods established under Sections 4 and 5 of this bylaw do not begin until the day after the date that the second copy of the Bylaw Notice is issued to the person.

#### **BYLAW NOTICE DISPUTE ADJUDICATION SYSTEM**

- 6 (1) The Bylaw Notice Dispute Adjudication System is established in accordance with Section 14 of the *Act* to resolve disputes in relation to Bylaw Notices.
  - (2) The civic address of the Bylaw Notice Dispute Adjudication System/Registry is 202 Lakeside Drive, Nelson, BC.
  - (3) All processes, procedures, hearings and determinations will be in accordance with the *Act*. In the event of inconsistency between the *Act* and the bylaw, the *Act* shall apply to the extent of the inconsistency, but this bylaw shall not be deemed inconsistent if the person who complies with the bylaw does not, by this, contravene the *Act*.
  - (4) The Registry will administer the dispute adjudication system and disputes will be heard by a bylaw notice dispute adjudicator in the circumstances prescribed in the *Act* and authorizing bylaws.
  - (5) The Regional District shall enter into a contract with the Attorney General to provide an adjudicator from the provincial roster of adjudicators who will be assigned to individual disputes in the manner prescribed by established regulation.
  - (6) Every person who is unsuccessful in dispute adjudication in relation to a bylaw notice or compliance agreement under the adjudication system established under this section must pay the Regional District an additional fee of \$25.00, as permitted under Section 23(2) of the *Act*, for the purpose of the Regional District recovering a portion of the costs of administering the Bylaw Notice Dispute Adjudication System.

#### **SCREENING OFFICERS**

- 7 (1) Pursuant to Section 10 of the Act, the position of Screening Officer is established.
  - (2) Anyone within the following classes of persons may be appointed as a Screening Officer:
    - (a) Managers of the Regional District; and
    - (b) Persons designated as Bylaw Enforcement Officers under Section 9 of this Bylaw.

#### **POWERS, DUTIES AND FUNCTIONS OF SCREENING OFFICERS**

- **8** (1) The powers, duties and functions of Screening Officers are as set out in the *Act* and its regulations, and include the following powers:
  - (a) Where requested by the person against whom a contravention is alleged:
    - (i) Communicate information respecting the nature of the contravention:
    - (ii) Provide a copy or reference to the bylaw contravened;
    - (iii) Outline the facts on which the contravention allegation is based;
    - (iv) Confirm the penalty for a contravention;
    - (v) Where permitted, provide the opportunity to enter into a compliance agreement;
    - (vi) Provide the opportunity to proceed to the bylaw notice dispute adjudication system; and
    - (vii) Confirm the fee or fees payable in relation to late payments or the bylaw notice dispute adjudication system.
  - (b) To communicate with any or all of the following for the purposes of performing their functions under this bylaw or the *Act*:
    - (i) The person against whom a contravention is alleged or their representative;
    - (ii) The officer issuing the Notice;
    - (iii) The complainant or their representative; or
    - (iv) The Regional District staff and records regarding the disputant's history of bylaw compliance.
  - (c) Where permitted, to prepare and enter into compliance agreements under the Act with persons who dispute bylaw notices, including establishing terms and conditions for compliance the Screening Officer considers necessary or advisable, including timing of payment of penalties and achieving compliance with the bylaw;
  - (d) To provide for payments of a reduced penalty if a compliance agreement is entered into, as provided by Column A4 of Schedule A; and
  - (e) To cancel bylaw notices in accordance with the *Act* or Regional District policies and guidelines.
  - (2) The bylaw contraventions in relation to which Screening Officer may enter into a compliance agreement are indicated in Column A4 of Schedule A.
  - (3) The maximum duration of a compliance agreement is one year.

#### **BYLAW ENFORCEMENT OFFICERS**

- 9 (1) For the purposes of this bylaw, Bylaw Enforcement Officer means any of the following;
  - (a) Members of a municipal police force;

- (b) Members of the Royal Canadian Mounted Police;
- (c) Local Assistants to the Fire Commission under Section 6 of the Fire Services Act;
- (d) Fire Chief or Deputy Fire Chief; or
- (e) Persons appointed as Bylaw Enforcement Officers, Building Inspectors, Animal Control Officers or other persons acting in another capacity on behalf of the Regional District for the purpose of enforcement of one or more of the Regional District's bylaws.
- (2) No person shall obstruct or interfere with a Bylaw Enforcement officer in the exercise or performance of their powers, duties or functions under this Bylaw and Act.

#### FORM OF BYLAW NOTICE

10 The Regional District may from time to time provide for the form or forms of the bylaw notice, provided the bylaw notice complies with Section 4 of the Act.

#### **SCHEDULES**

11 The following schedules are designated to and form part of this bylaw:

**Schedule A:** Designated Bylaw Contraventions and Penalties

Schedule B: Compliance Agreement

#### **REPEAL**

12 "Regional District of Central Kootenay Bylaw Enforcement Notice and Dispute Adjudication System Bylaw No. 2441, 2015" and any amendments thereto are hereby repealed.

#### **SEVERABILITY**

13 If a portion of this bylaw is held invalid by a Court of competent jurisdiction, then the invalid portion must be severed and the remainder of this bylaw is deemed to have been adopted without the severed section, subsection, paragraph, subparagraph, clause or phrase.

#### **CITATION**

14 This bylaw may be cited for all purposes as "Regional District of Central Kootenay Bylaw Enforcement Notice and Dispute Adjudication System Bylaw No. 2855, 2023."
