Any work not yet completed must comply with current Building Code.

Ø		Total cost of construction remaining	Provide on application form.  To be calculated at current market rates, including all labour, material, trades and professional fees.
Ø		Outstanding Permit Documents	Provide all outstanding documents required for previous inspections, such as:  Plumbing Test Certificate Engineer and Architect review letters Ventilation checklist and heating certificate Septic Certification Confirmation of completion of electrical and gas permits
团		Construction Drawings	Include a new set of drawings if the plans have changed from the original approved plans. This includes: suite or washroom added, revised floor layout, additional plumbing fixtures, changes to exterior opening, basement to be finished, etc.  Provide the revised drawings in PDF format. If unable to provide a digital copy, submit 2 sets of physical drawings no larger than 11"x17".
