Changes to 9.32 Ventilation in the BC Building Code

The BC Building Code section 9.32 includes new provisions to ensure that the whole house maintains comfortable, safe living conditions for occupants. 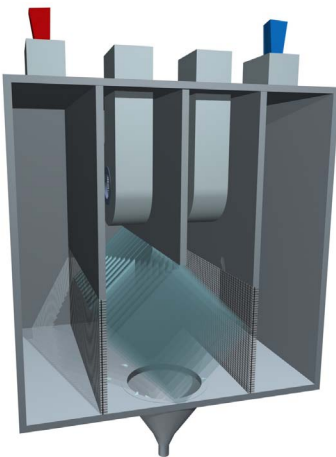
