The Regional District of Central Kootenay has been advised that the imminent danger of Wildfire to the life and property of persons, resident or present of the **Octopus Creek Evacuation Order, Electoral Area K**, has diminished at this time.

The Evacuation Order, pursuant to Section 10(1)(h) of the Emergency Program Act, to evacuate **Applegrove, RDCK Electoral Area K** which includes 5 addresses south of Taite Creek on Applegrove Road, therefore, been has rescinded and downgraded to an Evacuation Alert.

170 properties which includes the following addresses (refer to attached map), in the areas of **Applegrove and Fauquier, RDCK Electoral Area K** remain on Evacuation Alert.

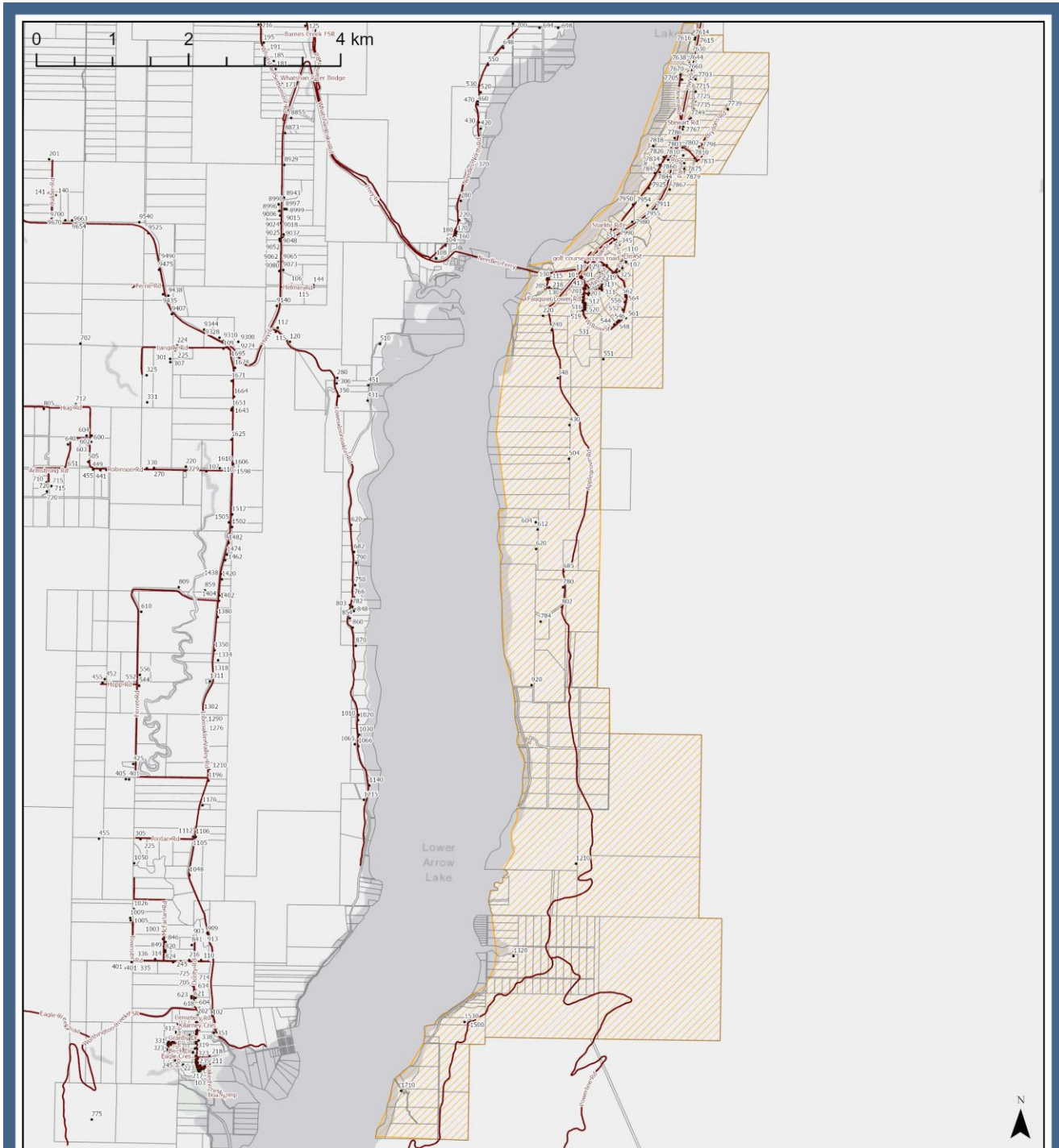
In the event that conditions change an Evacuation Order may be re-issued and the evacuation process will re-commence.
