Option A – Step 2 +

Build a home to BC Energy Step Code 2 or higher using natural gas space and water heating (or electricity space and water heating in FortisBC's electricity service area)

Option B – Step 1

Build a Home to BC Energy Step Code 1 and select from the following rebates

Apply through FortisBC for buildings completed before December 31, 2021.

Energy Step Code Pathway

Build a home to BC Energy Step Code using electric space and water heating systems

Heat Pump Pathway

Build a home that uses an electric heat pump for space heating or water heating.

Apply through CleanBC. Available for buildings that pre-register by March 31, 2022.

Step 1 [†]	\$500	Air source heat pump*	\$3,000
Step 2 [†]	\$3,000	Air-to-water hydronic heat pump*	\$3,000
Step 3	\$4,000	Combined space and water heat pump*	\$4,000
Step 4	\$6,000	Heat pump water heater*	\$1,000
Step 5	\$10,000		

3. In addition to the above, you may also be eligible for more bonus upgrades. Check out these additional rebates.

Energy Advisor Support Rebate

\$500 per individually modelled home or unit (\$100 paid to the Energy Advisor / \$400 paid to the builder)

Design Incentive Offer - Step 3, 4 & 5

Builders can receive up to \$7,000 for Integrated Design Process (IDP) consultants, building science consultants and/or mechanical design specialists fees on individual homes. Multi-family projects can receive up to \$50,000.

New Housing Rebates

Tax Rebate Program

1. Is your new home your primary residence and valued under \$450,000?



GST/HST New Housing Rebate Program

Through the Federal and Provincial Government GST/HST New Housing Rebate Program, you may be eligible to receive a new housing rebate for some of the GST/HST paid for new constructed or substantially renovated residential homes **for use as your primary place of residence and the fair market value of the home when construction is complete is less than \$450,000.**

Other provincial new housing rebates may also be available for the provincial part of the HST.

Mortgage Insurance Rebate Program

Canada Mortgage and Housing Corporation

The Canada Mortgage and Housing Corporation's Green Home Program provides either a 15% or 25% premium refund on your mortgage loan insurance when you purchase or construct a new home or renovate for energy efficiency that meets or exceeds eligible building standards.

Genworth Mortgage Loan Insurance

The Genworth Energy-Efficient Housing Program provides either a 15% or 25% premium refund on your mortgage loan insurance when you purchase a new home built under a qualifying energy efficient building program.

Build a home to a recognized building standard accreditation

Apply through CMHC within 24 months of mortgage closing date with documentation not older than 5 years

Building Standard Pathway

Build a home to a recognized building standard accreditation



Non-Building Standard Pathway

Build a home to a high performance level, but not under a building standard accreditation

Apply through Genworth Canada within 24 months of mortgage closing date with documentation not older than 5 years
